RESIDENTIAL INGROUND AND ABOVE GROUND SWIMMING POOL, SPA AND HOT TUB SAFETY ACT NOTICE OF REQUIREMENTS

I (We) acknowledge that a new swimming pool, spa or hot tub will be constructed or installed at _____, and hereby affirm that one or more of the

following methods will be used to meet the requirements of Chapter 515, Florida Statutes and Section 424.2, Florida Building Code. I understand that the method(s) used must be shown on the plan submitted for review by a plans examiner. (Please initial the method(s) to be used for your pool.)

_____ The pool, spa or hot tub shall be isolated for access from the home and surrounding neighboring properties by an enclosure i.e. fence, screen enclosure, child barrier fence, that meets the pool barrier requirements of Florida Statute 515.29 and Florida Building Code Section 424.2.17 (Type of enclosure(s) must be shown on the plan);

_____ The pool will be equipped with an approved safety pool cover that complies with ASTM F1346-91 (Standard Performance Specifications for Safety Covers for Swimming Pools, Spas and Hot Tubs);

_____ All doors and windows providing direct access from the home to the pool will be equipped with an exit alarm complying with UL 2017 that has a minimum sound pressure rating of 85 decibels at 10 feet.

_____ All doors providing direct access from the home to the pool will be equipped with self-closing, self-latching devices with positive mechanical latching/locking installed a minimum of 54" above the threshold, which is approved by the authority having jurisdiction. All doors and windows leading to the pool must be shown on the plans.

I understand that not having one or more of the above installed at the time of final inspection, or when the pool is completed for contract purposes, will constitute a violation of Chapter 515, F. S., and will be considered as committing a misdemeanor of the second degree, punishable by fines up to \$500 and/or up to 60 days in jail as established in Chapter 775, F. S.

I also understand that failure to comply is also a violation of the Florida Building Code and Hernando County Ordinance and may be punishable by fines ranging from \$500-\$5,000 and disciplinary action.
