The Community Transit Workshops will provide the public the opportunity to review and comment on the current fixed-route service and the proposed changes to the transit system. The public is encouraged to attend, participate, and comment on the issues and role of mass transit serving Hernando County. The workshops will address the proposed service and route modifications as follows:

**Implementation Anticipated April 2012**

- Improve system headways from 120 minutes to 75 minutes
- Extend service to access the Pasco-Hernando Community College (PHCC) Spring Hill campus on US 19, and to the Seven Hills Plaza at Mariner Blvd. and County Line Rd.
- Provide continuous service from Brooksville to Spring Hill without the need for a transfer at Mariner Square
