I, Alan Krasemann and my wife Lois Krasemann are requesting a conditional use permit for five acres of which we have pending sale contract on, contingent upon approval of the conditional use permit.


The conditional use permit is requested because our daughter and two grandchildren need to live close to us due to their medical problems. Each one has been diagnosed with "Myasthenia Gravis (MG) which is a primary disorder of neuromuscular transmission. It is and autoimmune disease with the course of disease being variable but usually progressive. Both of the grandchildren ages eight and eleven have had four and three eye surgeries respectively, to tighten the muscles. All three have times of muscles weakness. Our granddaughters legs will, at times, give out instantly and she will need to be carried or use her wheel chair. Our grandson has heaviness feelings in his neck, arms, legs, but worst of all is when he has a respiratory attack of which his throat closes off and he cannot breath out. This requires **immediate** breathing treatment and a special injectable medicine to open the throat muscles temporarily.

Our daughter, who is a single parent, was just diagnosed with the same disease within this last year, the grandchildren since ages four & seven.

These three people need to be close to us for immediate help, as there are no warning signs to when these symptoms will happen.

Therefore my wife and I request the approval of Conditional Use Permit, to allow our residence plus a second residence on this five acre parcel indefinitely until our daughter and grandchildren's conditions improve or their situation changes that there is not a need for us to be there for them twenty-four hours a day.
