NOTICE IS HEREBY GIVEN that the Board of County Commissioners of Hernando County will open sealed bids at **3:00 P.M., LOCAL TIME, WEDNESDAY, JANUARY 27, 2010**, in the Hernando County Purchasing / Technology Services Conference Room, located in the Government Center, 20 N. Main Street, Room 361, Brooksville, Florida, for the **Hernando Beach Volunteer Fire Department Building Addition. Provide a 50 foot by 50 foot steel building with two 12' x 12' overhead doors, two 14' x 14' overhead doors, one 3' x 7' steel door and one walk thru doorway, and permits. Provide engineered slab drawings for foundation not less than 8" thick of reinforced concrete to support a 60,000 lb fire tanker. Construct a driveway connection to the existing parking lot.**

Sealed bid offers in two (2) copies for furnishing the aforesated work will be received and accepted by the Hernando County Clerk of Circuit Court, 20 North Main Street, Room 131, Brooksville, Florida 34601, until the above stipulated date and time for opening of sealed bids. For all hand-delivered bids, the Clerk's Office is open, on normal workdays, between the hours of 8:00 A.M. and 5:00 P.M.



Bid offers shall be accompanied by either a Proposal Bond or by a Certified Check or a Cashier's Check or an Official Bank Check in the dollar amount representing not less than five percent (5%) of the total amount bid as a guarantee to enter into a contract and furnish a contract performance and payment bond in the amount of one hundred percent (100%) of the total bid price within fifteen (15) calendar days from the date of notification of the award.

A prebid conference will be held **THURSDAY, JANUARY 7, 2010, @ 10:00 A.M.**, at the **Engineering Division Office**. Representatives of COUNTY and Engineer will be present to discuss the project. Bidders are encouraged to attend and participate in the conference. The Engineer will transmit to all prospective Bidders of record such addenda as Engineer considers necessary in response to questions arising at the conference.
