NOTICE IS HEREBY GIVEN that the Board of County Commissioners of Hernando County will open sealed bids at **3:00 P.M., LOCAL TIME, WEDNESDAY, MARCH 24, 2010**, in the Hernando County Purchasing and Contracts/Technology Services Conference Room, located in the Government Center, 20 N. Main Street, Room 361, Brooksville, Florida, for the **BIKE TRAILHEAD RESTROOM AT US98/SUNCOAST CORRIDOR**. Work is to include: Construction of a restroom facility/pavilion (approx. 1142 s.f.), well house (approx 100 sq.ft), approaching walks, related grading, septic system, well, sodding and appurtenances. **This project is subject to the Davis-Bacon Act.**

Sealed bid offers in two (2) copies for furnishing the aforesated work will be received and accepted by the Hernando County Clerk of Circuit Court, 20 North Main Street, Room 131, Brooksville, Florida 34601, until the above stipulated date and time for opening of sealed bids. For all hand-delivered bids, the Clerk's Office is open, on normal workdays, between the hours of 8:00 A.M. and 5:00 P.M.

Bid offers shall be accompanied by either a Proposal Bond or by a Certified Check or a Cashier's Check or an Official Bank Check in the dollar amount representing not less than five percent (5%) of the total amount bid as a guarantee to enter into a contract and furnish a contract performance and payment bond in the amount of one hundred percent (100%) of the total bid price within fifteen (15) calendar days from the date of notification of the award.

A one time **MANDATORY** prebid conference will be held **THURSDAY, MARCH 4, 2010, @ 2:00 P.M.**, at the **Engineering Division Office**. Representatives of COUNTY and Engineer will be present to discuss the project. Bidders are **REQUIRED** to attend and participate in the conference. **THIS CONFERENCE WILL BE HELD ONLY ONCE AND FAILURE TO ATTEND AND SIGN-IN SHALL DISQUALIFY ANY BIDDER NOT ATTENDING FROM SUBMITTING BID.** The Engineer will transmit to all prospective Bidders of record such addenda as Engineer considers necessary in response to questions arising at the conference.
