CLARIFICATIONS

1. All plan sheets are included in the PDF documentation on the CD. However, sheet labeled 27 of 27 (SWPPP DETAILS) is mislabeled and should be sheet 26 of 27.
2. The Roadway Connection Legend uses the Milling and Tie-In Detail on sheet 4 of 36 as the method of construction. Payment shall be under the Pay Item No 327-70-6 Milling.
3. This is a Unit Cost construction project.
4. FDOT Pre-Qualification is not required.
5. There are no specific permit fees.
6. As-builts are not required for this project.
7. Videos or still photos not required for this project.

8. FDOT Asphalt Index (API) is not part of this contract. No adjustment of asphalt pricing allowed.
9. The contractor takes possession of milled asphalt materials.
10. All equipment and operations must comply with FDOT Standard Specifications for Road & Bridge Construction, 2007 Division II & Division III.
11. Lane closures will not be allowed between the hours of 6:00 AM and 8:00 AM and between the hours of 4:00 PM and 6:00 PM.
