Main Street, Room 361 ,Brooksville, Florida, for the **Spring Lake Hwy (CR 541) Phase 3 Road Widening (SCOP- Small County Outreach Program) project. Work to Include: Widen 1.19 miles of roadway to 12' lanes, include 4' paved shoulders, milling, storm water extensions, under drains, base replacement, regrading shoulders and swales, sodding, temporary and permanent striping, and sign relocations.**

Bid offers shall be accompanied by either a Proposal Bond or by a Certified Check or a Cashier's Check or an Official Bank Check in the dollar amount representing not less than five percent (5%) of the total amount bid as a guarantee to enter into a contract and furnish a contract performance and payment bond in the amount of one hundred percent (100%) of the total bid price within fifteen (15) calendar days from the date of notification of the award.

Representatives of COUNTY and Engineer will be present to discuss the project. Bidders are encouraged to attend and participate in the conference.
