Bid offers shall be accompanied by either a Proposal Bond or by a Certified Check or a Cashier's Check or an Official Bank Check in the dollar amount representing not less than five percent (5%) of the total amount bid as a guarantee to enter into a contract and furnish a contract performance and payment bond in the amount of one hundred percent (100%) of the total bid price within fifteen (15) calendar days from the date of notification of the award.

A prebid conference will be held **MONDAY, OCTOBER 4, 2010, @ 10:00 A.M.**, at the **Engineering Division Office**. Representatives of COUNTY and Engineer will be present to discuss the project. Bidders are encouraged to attend and participate in the conference. The Engineer will transmit to all prospective Bidders of record such addenda as Engineer considers necessary in response to questions arising at the conference.
