US19 SOUTH WATER MAIN/FORCE MAIN EXTENSIONS PROJECT**

NOTICE IS HEREBY GIVEN that the Board of County Commissioners of Hernando County will open sealed bids at **3:00 P.M., LOCAL TIME, WEDNESDAY, MAY 4, 2011**, in the Hernando County Purchasing and Contracts Department, located in the Government Center, 20 N. Main Street, Room 361, Brooksville, Florida, for the construction of 13,000 linear feet of 12 inch diameter water main within US19 right-of- way including connection to existing services, fire hydrants, mains; adjustment of location and/or elevation of approximately 500 linear feet of 8 and 10 inch diameter water main and force main including connections to existing mains, valves, air releases, and other appurtenances to accommodate future FDOT project drainage improvements according to the Contract plans titled "US 19 South Water Main Extension", FDOT plans, and the project specifications. Construction of 11,200 linear feet of 16 inch diameter force main within US19 right-of-way from County Line Road to Tarpon Boulevard including connection to existing force mains according to the plans titled "SR55 (US 19) Force Main" and the project specifications.

Sealed bid offers in two (2) copies for furnishing the aforesated work will be received and accepted by the Hernando County Clerk of Circuit Court, 20 North Main Street, Room 131, Brooksville, Florida 34601-2800, until the above stipulated date and time for opening of sealed bids. For all hand-delivered bids, the Clerk's Office is open, on normal workdays, between the hours of 8:00 A.M. and 5:00 P.M.

CD's will be available to prospective bidders. Bid offers shall be accompanied by either a Proposal Bond or by a Certified Check or a Cashier's Check or an Official Bank Check in the dollar amount representing not less than five percent (5%) of the total amount bid as a guarantee to enter into a contract and furnish a contract performance and payment bond in the amount of one hundred percent (100%) of the total bid price within fifteen (15) calendar days from the date of notification of the award.

A **MANDATORY** pre-bid conference will be held **WEDNESDAY, APRIL 13, 2011, @ 10:00 A.M.**, at the **Hernando County Utilities Department, 21030 Cortez Blvd., Brooksville, Florida, 34601.** Representatives of Owner and Engineer will be present to discuss the project. Bidders are **REQUIRED** to attend and participate in the conference. **THIS CONFERENCE WILL BE HELD ONLY ONCE AND FAILURE TO ATTEND AND SIGN IN SHALL DISQUALIFY ANY BIDDER NOT ATTENDING FROM SUBMITTING A BID. ATTENDEES MUST BE PRESENT AT THE BEGINNING OF THE CONFERENCE. ARRIVAL AFTER THE START OF THE MEETING SHALL BE CAUSE FOR DISQUALIFICATION.**

The Engineer will transmit to all prospective Bidders of record such addenda as Engineer considers necessary in response to questions arising at the conference. **Bidders of Record** will be those Bidders who have received a compact disc from, and are included on, the list of plan holders maintained by the Hernando County Northwest Waste Management Facility. **ADDENDA WILL BE SENT VIA THE EMAIL ADDRESS ENTERED ON THE PLAN HOLDERS' LIST.** The Purchasing will post such Addenda on the County's website at www.hernandocounty.us; follow the link to "Public Bids". **It is the responsibility of the prospective Bidders to visit the County's website to insure that they are aware of all Addenda issued relative to this solicitation.**
