NOTICE IS HEREBY GIVEN that the Board of County Commissioners of Hernando County will open sealed bids at **3:00 P.M., LOCAL TIME, WEDNESDAY, APRIL 20, 2011**, in the Hernando County Purchasing and Contracts Department, located in the Government Center, 20 N. Main Street, Room 365, Brooksville, Florida, for the **SOUTH BROOKSVILLE VISION AREA PHASE I Project. Work is to include: Install 8" water main on St. Francis and Easy Streets to provide fire flow and replace existing undersize service lines. Install 8" gravity sewer on St. Francis and Easy Streets to replace existing septic systems. Restore streets and drainage features disturbed by utility construction.**

Sealed bid offers in two (2) copies for furnishing the aforesated work will be received and accepted by the Hernando County Clerk of Circuit Court, 20 North Main Street, Room 131, Brooksville, Florida 34601-2800, until the above stipulated date and time for opening of sealed bids. For all hand-delivered bids, the Clerk's Office is open, on normal workdays, between the hours of 8:00 A.M. and 5:00 P.M.


Bid offers shall be accompanied by either a Proposal Bond or by a Certified Check or a Cashier's Check or an Official Bank Check in the dollar amount representing not less than five percent (5%) of the total amount bid as a guarantee to enter into a contract and furnish a contract performance and payment bond in the amount of one hundred percent (100%) of the total bid price within fifteen (15) calendar days from the date of notification of the award.

A **MANDATORY** pre-bid conference will be held **WEDNESDAY, MARCH 23, @ 10:00 A.M.**, at the **Hernando County Utilities Department, 21030 Cortez Blvd., Brooksville, Florida, 34601.** Representatives of Owner and Engineer will be present to discuss the project. Bidders are **REQUIRED** to attend and participate in the conference. **THIS CONFERENCE WILL BE HELD ONLY ONCE AND FAILURE TO ATTEND AND SIGN IN SHALL DISQUALIFY ANY BIDDER NOT ATTENDING FROM SUBMITTING A BID. ATTENDEES MUST BE PRESENT AT THE BEGINNING OF THE CONFERENCE. ARRIVAL AFTER THE START OF THE MEETING SHALL BE CAUSE FOR DISQUALIFICATION.**
