Short Description of the Commodity or Service Desired:

uAvionix Corporation is the sole provider for the Flightline Airborne Position Reference Tool (APRT), including the site-specific system configuration, equipment, software/service access, installation, training, commissioning, warranty, maintenance, updates, and technical support required for use at the BKV Airport Traffic Control Tower (ATCT).

BKV operates a Federal Contract Tower in need of a Standard Terminal Automation Replacement System (STARS) Certified Tower Radar Display (CTRD). uAvionix is the only situational-awareness display with Federal Aviation Administration approval for federal and non-federal traffic control towers. No reasonably equivalent alternative has been identified that carries the same approval for the intended ATCT use and can provide the required end-to-end system and support. uAvionix enables controllers to visually locate aircraft and correlate reported positions with geographic references.

Total Estimated Amount: \$ 87,000.00 for first five years of the Contract
