- NPDES notice of intent.
- Copy of FDOT Letter of Intent (if accessing on State Road).
- Copy of Comprehensive Wildlife survey (if required) and identification of any required wildlife permits unless provided during Conditional Plat review.
- Provide rezoning and/or conditional plat conditions for distribution to effected agencies.
- List of planned improvements indicating those that will remain private and those dedicated to the County.
