MEETING CALLED TO ORDER

- Chair Herring called the meeting to order at 9:00 a.m. and led the Moment of Silence.
- The Pledge of Allegiance and the introductions of the Committee members and staff followed the Moment of Silence.
- A quorum was declared, and Ms. Turner noted for the record that the public notice for the meeting was posted in accordance with the adopted policies.

APPROVAL/MODIFICATION OF AGENDA

Motion: A motion was made by Vice Chair Eastmond to approve the agenda. The motion was seconded by Ms. Lollie and the motion passed 7-0.

REVIEW/APPROVAL OF THE MINUTES – AUGUST 29, 2024, TECHNICAL ADVISORY COMMITTEE (TAC) REGULAR PUBLIC MEETING

The minutes of the August 29, 2024, meeting of the TAC were provided for review and approval.

Motion: A motion was made by Ms. Lollie to approve the Minutes of the August 29, 2024, meeting. The motion was seconded by Mr. Shoemaker and the motion passed 7-0.

PRESENTATIONS

1. Presentation of Survey Results by the Center for Urban Transportation Research (CUTR) on the Hernando County FY2025-FY2034 Transit Development Plan (TDP)
Jonathan Roberson, AICP, Research Associate for CUTR, under contract with the Hernando County Board of County Commissioners to do the major TDP update, made a final presentation on the Hernando County Transit Development Plan (Hernando TDP) for FY 2025-FY 2034 outlining a number of priorities, short-term and longer-term needs, and overall recommendations. Chair Herring asked for a motion for endorsement of the TDP for fiscal year 2025 to fiscal year 2034.

Motion: A motion was made by Ms. Granger to endorse the Hernando County FY2025-FY2034 Transit Development Plan (TDP). The motion was seconded by Ms. Lollie and the motion passed 7-0.
2. Presentation by the Florida Department of Transportation on the Tentative Five-Year Work Program (FY 2026-FY 2030)
Elisa Joyner, Florida Department of Transportation, District 7, made a presentation on programming strategies and the proposed FDOT Tentative Five-Year Work Program for FY 2026 - FY 2030. A flyer provided by the Florida Department of Transportation for the public hearing process was included in the packets and is posted on the MPO's website. Ms. Joyner provided the web page for public comment which will be open December 9, 2024, through December 30, 2024.
3. Presentation by the Florida Turnpike Enterprise on the Tentative Five-Year Work Program (FY 2026-FY 2030)
Siaosi Fine from Florida Turnpike Enterprise (FTE) made a presentation on the proposed Tentative Five-Year Work Program for FY 2026 – FY 2030. His presentation included how projects are prioritized and funded. Mr. Esposito asked if the Suncoast Parkway Extension timeline had been accelerated. Mr. Fine explained the timeline had not changed but calendar year versus fiscal year was used in this year's presentation (i.e., 3rd quarter 2025 in today's presentation may have been previously shown as 1st quarter 2026). Chair Herring inquired on the status of the study to potentially add a Suncoast Parkway interchange at Centralia Avenue in Hernando County. Mr. Fine affirmed the application and supporting materials have been received and a study to determine the feasibility of adding an interchange will commence in 2025. In response to Chair Herring's question, Mr. Fine confirmed the study is separate from the work program.

ACTION ITEM

Annual Review and Update of the Technical Advisory Committee (TAC) Bylaws

Mr. Esposito reviewed the agenda item noting the major updates proposed to the Bylaws would be to add a Fire and Rescue member position for Hernando and Citrus counties and to update the non-voting staff advisor positions to voting positions. Vice Chair Eastmond shared that the premise of the Technical Advisory Committee is "*technical*" and was unsure of the benefit to add a Fire and Rescue position. Chair Herring relayed that adding member positions and moving non-voting positions to voting positions could have a negative impact on quorum requirements. Chair Herring emphasized the benefit of having Fire and Rescue participate in TAC meetings but suggested a non-voting capacity could be more appropriate. The TAC opted for the voting membership to remain unchanged, for non-voting staff advisor positions to remain non-voting, and to add Fire and Rescue positions for Hernando and Citrus Counties as non-voting staff advisor positions.

Motion: A motion was made by Vice Chair Eastmond to recommend the MPO Board approve the annual update to the TAC Bylaws, as indicated above. The motion was seconded by Mr. Shoemaker and the motion passed 7-0.

CITIZEN COMMENTS

There were no citizen comments.

COMMITTEE MEMBER COMMENTS

There were no further committee comments.

MPO STAFF UPDATES

Mr. Esposito shared the following updates:

- Similar to last year, MPO staff will be sending Outlook meeting notices for the 2025 meetings.
- The MPO team met with Curlene Thomas and Jean Parlow from FHWA for an on-site visit on August 28th. They were pleased with what the Hernando/Citrus MPO is doing, its regional participation with the Sun Coast Transportation Planning Alliance (SCTPA), along with conducting quarterly meetings with bordering Lake-Sumter MPO and Ocala Marion Transportation Planning Organization (TPO).
- The Florida Department of Transportation (FDOT), Pasco County, and Hernando County staff members will meet at the end of January to further discuss improvement for County Line Road in Hernando County.
- County Line Road has been added to the Regional Priorities List that will be presented at the Sun Coast Transportation Planning Alliance (SCTPA) meeting on December 6 at the Tampa Bay Regional Planning Council. Citrus County Commissioner Jeff Kinnard will be chairing the meeting.
- Improvements to the SR44/Turkey Oak intersection have been discussed with FDOT and will be added to the LOPP once a few of the current projects are completed.
- Mr. Esposito and Citrus County Commissioner Bays met with Ananth Prasad, President of the Florida's Transportation Builders' Association, on September 30th and State Senator Ed Hooper on October 30th.
- Mr. Esposito attended the Hernando County Town Hall meeting on Tuesday, October 22nd.
- Mr. Esposito was interviewed by WWJB radio on November 6th to discuss how roads are funded.

Vice Chair Eastmond mentioned FDOT had requested additional signal timing information for the intersection improvement being conducted at SR 44/CR 491 and inquired if FDOT could provide an update. Suzanne Ziegler, Florida Department of Transportation, District 7 liaison confirmed she would follow-up.

The next regular meeting of the Technical Advisory Committee (TAC) is tentatively scheduled for Thursday, January 23, 2025, beginning at 9:00 a.m., in the Hernando County Building Training Facility, 1661 Blaise Drive, Brooksville, Florida.
