- Update on hurricane efforts including conditions on the east side of the County (Withlacoochee River flooding), comfort stations, and current working locations.

NEW BUSINESS

1. WAC vacancy
 - Two positions will become vacant as of December 31, 2024.
 - Kathryn Birren's application was approved at the BOCC meeting on December 17, 2024.

2. Projects for FY25:

- Lake Townsen boat ramp:
- Canal maintenance study: Our consultant will evaluate the residential navigable canals West of US 19 in Hernando County. The scope of work will include completing hydrographic/bathymetric surveys, volume analyses, and a feasibility memo to summarize dredging recommendations and next steps.
 - Members asked if dredging was planned after this study. Potential activities will be dependent on results from the study.

3. Hurricane Helene and Milton damage

- Numerous signs missing – County staff are diligently working on installing missing/damaged signs throughout our waterways.
- Debris in waterways
- Park closures
 - Pine Island is closed.
 - Restrooms at Bayport, Jenkins Creek, Linda Pedersen, and Roger's Park are closed. Roger's Park play area is also closed. Bayport observation pier is closed.

OLD BUSINESS

4. Weeki Wachee River Dredge – final completion date is January 20, 2025.

- Members asked about the damage to the river from the hurricane. Numerous trees were removed by Waterways staff.
- Kathryn Birren asked about the complaints regarding Bass Canal. FDEP made a final determination that the pipes from George Foster property were not contributing to degradation of water quality to the Weeki Wachee River.

5. Harvesting Vessel – Hunter's Lake
